# **Aragon Proposed Development - Current Status**

- 3. Subdivision SUB00972

### Purpose:

TO REZONE FROM M-2, P-4 AND RM-3T TO A COMPREHENSIVE DEVELOPMENT ZONE FOR A MULTI-PHASED COMPREHENSIVE DEVELOPMENT WITH A MIX OF LOW-RISE TOWNHOUSES AND ROW HOUSES AND MID-RISE MULTI-FAMILY RESIDENTIAL BUILDINGS WITH COMMERCIAL RETAIL, OFFICE AND DAYCARE USES

# The Developer's Proposal

Aragon is proposing to build 29 buildings comprising 1,160 units as follows:

- 12 3-Storey buildings
- 6 5-Storey buildings
- 6 6-Storey buildings
- 2 10-Storey buildings
- 3 11-Storey buildings

The developer's Rationale Letter and site maps, studies and other documents can be found attached to the Development permit further describing the overall development plan and its rationale.

# **Community Association Referral Package**

On July 25, 2025 the Cordova Bay Association for Community Affairs received a Community Association Referral Package from the District of Saanich containing the above proposed plans for review and comment. We have until September 30<sup>th</sup> to respond.

Given the number of internal and external reviews we expect this to be a long process – Saanich estimates up to a year - before the proposal comes before council. CBACA will provide a submission to the mayor and council when the application comes before council.

Saanich has no cap on the number of people registering to speak to a specific agenda item, but pre-registration will be required.
